

R.C. 3345.0214(A)

Report Submitted by Northwest State Community College

- (1) Northwest State Community College has complied with R.C. 3345.0212 by taking the following actions:
 - Northwest State Community College does not prohibit any member of the Campus Community from engaging in noncommercial expressive activity on campus, so long as the individual's conduct is lawful and does not materially and substantially disrupt the functioning of the institution.
 - Northwest State Community College does not charge a security fee to any students or student groups based on the content of their expression, the content of the expression of their invited guest, or the anticipated reaction to an invited guest's expression.
 - Northwest State Community College has adopted a policy on harassment that adheres to the R.C. 3345.0211 definition.
 - Northwest State Community College has published in its handbook, on its website, and in its orientation programs the policies, regulations, and expectations of students regarding free expression on campus.
 - Northwest State Community College has developed and distributed materials, programs, and procedures about the policies, regulations, and duties of the institution regarding free expression on campus to individuals responsible for the education or discipline of students.
- (2) Northwest State Community College has complied with R.C. 3345.0213 by taking the following actions:

- Northwest State Community College does not limit Campus Community speech to "free speech zones" or designate Outdoor Areas of Campuses where expressive activities are prohibited.
- Northwest State Community College has published criteria for viewpoint and content-neutral time, place and manner restrictions that provide for ample alternative means for expressive activity that allow for members of the campus community to spontaneously and contemporaneously assemble and distribute material.
- (3) Northwest State Community College provides the following description of any barriers to or incidents of disruption of free expression occurring on campus, including attempts to block or prohibit speakers and any investigation of students or student groups on the basis of expression, including the nature of each barrier or incident and the disciplinary action, if any, taken against members of the campus community determined to be responsible for the barriers or incidents:
 - There have been no reported barriers to or incidents of disruption of free expression occurring on campus. There have been no attempts to block or prohibit speakers. There have been no investigations of any students or student groups on the basis of expression.
- (4) Northwest State Community College provides the following information it finds necessary and appropriate for the public to evaluate whether the free expression rights for members of the campus community have been adequately protected.

NORTHWEST STATE COMMUNITY COLLEGE POLICY AND PROCEDURES MANUAL

Policy No. 17-05: EXPRESSIVE ACTIVITIES AND HARASSMENT

Effective Date: 08/27/2021

- (A) This policy applies to Northwest State Community College students, student groups, faculty, staff and employees.
- (B) Ohio Revised Code 3345.0212 requires each public college in Ohio to adopt a policy on harassment that is consistent with and adheres strictly to the definition of harassment in section 3345.0211 of the Ohio Revised Code.
- (C) Northwest State Community College believes that the right of expression is as necessary as the right of inquiry and that both must be preserved as essential to the pursuit and dissemination of knowledge and truth. However, NSCC's commitment to freedom of expression does not extend to harassment. Under section 3345.0211, harassment is defined as conduct and/or expression that is:
 - (1) not protected by the First Amendment to the United States Constitution or Article I of the Ohio Constitution (Unprotected Expression);
 - (2) unwelcome; and
 - (3) so severe, pervasive, and objectively offensive that it effectively denies an individual equal access to the individual's education program or activity.
- (D) Expression (either in person, in writing or by telecommunication) must meet all three elements to be actionable under this policy. This policy applies to alleged harassment that takes place on Northwest State Community College's property (owned, leased, or controlled premises), at Northwest State Community College's sponsored events, and in connection with a Northwest State Community College's recognized program or activity.
- (E) Students should report alleged violations of this policy to the Vice President for Enrollment Management and Student Affairs. Faculty and Staff should report alleged violations of this policy to the Vice President for Human Resources & Leadership Development.
- (F) This policy shall not be construed to impair any right or activity, including speech, protest, or assembly protected by the U.S. Constitution.

- (G) Nothing within this policy shall be interpreted as preventing Northwest State Community College from restricting expressive activities that the First Amendment of the U.S. Constitution or Article I, Sections 3 and 11 of the Ohio Constitution does not protect. Further nothing in this policy shall be interpreted as restricting or impairing the College's obligations under federal law including, but not limited to, Title IV of the Higher Education Act of 1965, Title VI of the Civil Rights Act of 1964, Title VII of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, Section 504 of the Rehabilitation Act of 1973, Title II of the Americans With Disabilities Act, Age Discrimination in Employment Act and the Age Discrimination Act of 1975 as addressed through its non-discrimination and Title IX policies.
- (H) The President may adopt procedures to administer this Policy.

- Approved a \$5 per credit hour tuition increase for the 2021-2022 academic year for in-state and out-of-state students. New tuition amounts will be \$182.33 for in-state, \$358.66 for out-of-state.
- Approved Expressive Activities and Harassment Policy, and an Admissions Policy update for readmissions for service members and reservists who are called to mobilization or active duty.
- Approved miscellaneous employment contracts, and three resignations.

Senate Bill 40 (SB40) Fostering Open and Robust University Minds (FORUM) Act Compliance and Expressive Activities and Harassment Policy

Northwest State Community College (NSCC) believes that the right of expression is as necessary as the right of inquiry and that both must be preserved as essential to the pursuit and dissemination of knowledge and truth. To that end, NSCC does not prohibit any member of the campus community from engaging in noncommercial expressive activity on campus, so long as the individual's conduct is lawful and does not materially and substantially disrupt the functioning of the institution.

NSCC has adopted a policy on harassment (Policy 17-05) Expressive Activities and Harassment (Effective 8/27/21) as follows:

Policy No. 17-05: EXPRESSIVE ACTIVITIES AND HARASSMENT

Effective Date: 08/27/2021

- (I) This policy applies to Northwest State Community College students, student groups, faculty, staff and employees.
- (J) Ohio Revised Code 3345.0212 requires each public college in Ohio to adopt a policy on harassment that is consistent with and adheres strictly to the definition of harassment in section 3345.0211 of the Ohio Revised Code.
- (K) Northwest State Community College believes that the right of expression is as necessary as the right of inquiry and that both must be preserved as essential to the pursuit and dissemination of knowledge and truth. However, NSCC's commitment to freedom of expression does not extend to harassment. Under section 3345.0211, harassment is defined as conduct and/or expression that is:
 - (1) not protected by the First Amendment to the United States Constitution or Article I of the Ohio Constitution (Unprotected Expression);
 - (2) unwelcome; and
 - (3) so severe, pervasive, and objectively offensive that it effectively denies an individual equal access to the individual's education program or activity.
- (L) Expression (either in person, in writing or by telecommunication) must meet all three elements to be actionable under this policy. This policy applies to alleged harassment

that takes place on Northwest State Community College's property (owned, leased, or controlled premises), at Northwest State Community College's sponsored events, and in connection with a Northwest State Community College's recognized program or activity.

- (M) Students should report alleged violations of this policy to the Vice President for Enrollment Management and Student Affairs. Faculty and Staff should report alleged violations of this policy to the Vice President for Human Resources & Leadership Development. See below for details.
- (N) This policy shall not be construed to impair any right or activity, including speech, protest, or assembly protected by the U.S. Constitution.
- (O) Nothing within this policy shall be interpreted as preventing Northwest State Community College from restricting expressive activities that the First Amendment of the U.S. Constitution or Article I, Sections 3 and 11 of the Ohio Constitution does not protect. Further nothing in this policy shall be interpreted as restricting or impairing the College's obligations under federal law including, but not limited to, Title IV of the Higher Education Act of 1965, Title VI of the Civil Rights Act of 1964, Title VII of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, Section 504 of the Rehabilitation Act of 1973, Title II of the Americans With Disabilities Act, Age Discrimination in Employment Act and the Age Discrimination Act of 1975 as addressed through its non-discrimination and Title IX policies.
- (P) The President may adopt procedures to administer this Policy.
